

ORDINANCE NO. 10-447

AN ORDINANCE AMENDING THE
TAYLOR, MICHIGAN, ZONING ORDINANCE,
BEING APPENDIX A, OF THE TAYLOR CODE OF ORDINANCES
AMENDING ARTICLE 18.00 ENTITLED, SIGNS, Section 18.03, Prohibited Signs,
by adding a new subsections 18.03(o), (p) & (q)

THE CITY OF TAYLOR ORDAINS:

SECTION 1. That Article 18.00, SIGNS, Section 18.03 Prohibited Signs, of Appendix A of the Taylor, Michigan Code of Ordinances, be amended as follows:

Section 18.03 Prohibited Signs

Section 18.03 Prohibited Signs

- (o) Signage painted on exterior walls.
- (p) Signs which contain, words, lettering, photographs, silhouettes or drawings or pictorial representations of any specified anatomical area or sexually explicit activity as defined in this ordinance.
- (q) Signs advertising use or items which are illegal by state, federal or municipal law.

SECTION 2. Repeal. All ordinances and parts of ordinances in conflict with the provisions set forth herein are hereby repealed to the extent of such conflict.

SECTION 3. Savings Clause. Should any section, clause or phrase of this ordinance be declared by a Court of competent jurisdiction to be invalid, the declaration by said Court shall not affect the validity of this ordinance as a whole or any part thereof other than the part so declared to be invalid.

SECTION 4. Publication and Effective Date. This ordinance shall become effective upon passage by the City Council and publication of the ordinance in accordance with the Charter of the City of Taylor and the statutes of the State of Michigan.


